(Hereinafter called Principal) the undersigned, guarantor or guarantors, jointly and severally, individually and unconditionally guarantee payment in full, of all present and future indebtedness of any kind or nature of the principal to PLT Concrete Services, Inc. after maturity, including but not limited to all costs, expenses, finance charges, court costs and reasonable attorney fees of fifteen percent (15%) of the balance then due and owing in the event this account goes into default and is given over to an attorney or collection agency to collect the debt whether suit or action at law is instituted or not.

This Guaranty Agreement is absolute, unconditional and a continuing guaranty of payment and not of collection. The obligation of the guarantors hereunder shall be binding notwithstanding any of the following: (1) the granting of an extension of time for payment, (2) written or oral alteration or modification of the principal obligation, and (3) failure to give notice to the guarantor(s) of default or nonpayment by principal and any other notice of any kind whatsoever. This shall be an open and continuing guaranty. This guaranty shall become enforceable upon the default of the principal to make payments of any indebtedness to PLT Concrete Services, Inc. and its affiliates as they become due. Guarantors expressly waive any right to require PLT Concrete Services, Inc., to bring any action or suit against Principal. Guarantors waive all rights under N.C.G.S. § 26-7.

The obligation of each guarantor jointly and individually shall continue and may only be revoked by written notice of termination to PLT Concrete Services, Inc. served via certified mail, return receipt requested and shall then only terminate as to such guarantor giving notice, and only as to such indebtedness incurred by the principal subsequent to the date that such termination was received. Any such revocation shall become effective 15 days after receipt of said revocation. Upon receipt by PLT Concrete Services, Inc. of a guarantor(s) termination of guaranty of the principal, PLT Concrete Services, Inc. reserves the right in its sole discretion and without further notice to refuse to extend further credit to the principal and declare all outstanding balances of credit immediately due and owing.
